Abstract:

All around the world, frequently occur different type of tower crane accident cases in recent years. In 2023, near 70 recorded cases. Tower crane safety should be pay attention again in the coming day.

The speaker will share the key components that may minimize the occurrence of the tower crane accidents and explaining the responsibilities of Tower Crane stakeholder. He will summarize of different accident categories by using some international and domestic accidents cases for discussions.

Tower Crane related technology development rapidly at worldwide include Mainland, the new technology can help stakeholders be easily, faster, and efficiently to monitor & control tower crane. The development would become beneficial and contribution to construction and operation safety.
